Commission: HomeGrown31 is seeking proposals from West Midlands based artists/creatives aged 18 - 35 to create innovative socially engaged or issue driven art.

Commissions £500.00 - £2000.00 (April 2022- August 2022) Deadline for enquiries (including for access support): Friday 18th March 2022 DEADLINE FOR APPLICATIONS: Friday 25th March 2022 @ 10am

The commissions must respond to at least one of the below themes:

- Youth of the Future
- Mental Health
- Changemaking or Social Action
- Politics and Activism
- Identity and Culture
- Community

The commissions should be creative responses to the themes utilising at least one of the main art forms:

- Music (Instrumental)
- Visual Art (Painting/ Sculpture/ Plastic/Decorative)
- Literature (Storytelling)
- Theatre/Theatre Making
- Fashion/ Textiles

Please note we are strategically prioritising the above arts forms, multi/combined arts projects will be considered.

HomeGrown31 will be distributing a commissioning pot of up to £20,000.00 in the following four categories:

- Step Up Commissions (to evolve creative ideas from brand new artists\*): £500.00+ bespoke CPD
- Show it (site specific response about the Black Country): £500.00 £1,000.00
- Speak Out Commission (to discuss current social, cultural or political affairs): £500.00 -£1,000.00
- Stand together (Community Commissions to accelerate creative ideas or bring something to life with a named community/group of interest): £1,000.00 £2,000.00

\*A brand new artist may be someone who has never been commissioned before, has graduated from university within the past year, has formed a new company/collective within the past 6 months, or similar. This commission category will have the opportunity for extra artistic support/ direction in delivering the project, in whatever area they feel will be beneficial

If you applied to our previous commissioning cycle and were unsuccessful, you are welcome to reapply with a new or developed idea. Previous successful applicants are not eligible for this round of commissions.

Additional Information:

- CAN (HomeGrown31) welcomes applications from people living in all areas of the West Midlands and from all backgrounds.
- All work to be undertaken in the West Midlands.
- HomeGrown31 will support artists to ensure they are working within appropriate COVID-19 government guidelines, it is each artist's responsibility to ensure that appropriate risk assessments, policies and procedures are followed
- If commission undertaken works with children, young people and/or vulnerable communities artists/creatives will be expected to obtain a DBS
- Artists working in public spaces will be expected to obtain Public Liability Insurance of up to £5 million, HomeGrown31 can support young artists to obtain short-term insurance policies (please request support within your application)
- Commissions should begin in April 2022 and be completed no later than August 2022. Fee is inclusive of VAT
- Creative Academies Network will contract the appointed individual(s), who will be responsible for their own Tax and National Insurance.
- All successful applicants will be expected to attend a mandatory residency weekend in May to encourage creative collaboration between artists.
